# **INSTRUCTIONS WITH REGARD TO SUBMISSION OF TENDER** 1. ELIGIBILTY CRITERIA:

Bids are invited only from vendors/suppliers who fulfil the following eligibility criteria:

- a) The products offered should comply with the specifications indicated in **Annexure I**. The bidder should submit supporting documents along with the Technical Bid.
- b) The Vendor/Bidder/Service Provider should not have been blacklisted by any Central/State Government Organization or PSU for any corrupt and fraudulent practice. An Undertaking by the Authorized Signatory on the letter head of the Vendor/Bidder/Service provider should be submitted as a part of Technical Bid (Annexure III).
- c) The Vendor/Bidder/Service provider should mandatorily furnish pre-contract Integrity Pact as per format in Annexure VII. The Vendor/Bidder has to submit the same duly signed on a non-judicial stamp paper of Rs.500/- at the time of submission of the bid.
- d) All bidders, regardless of whether they share land border with India or not, are required to mandatorily submit Self Declaration Certificate (in respect of self as well as OEMs whose product they are offering) as per the format given in Annexure V and Annexure VI. ## 2. EARNEST MONEY DEPOSIT (EMD):

## **3. CONFIDENTIALITY:**

The details of the proposed purchase shall be treated as confidential information between NABFINS LIMITED and Vendor/Bidder. Any such information shall not be passed on in part or in full to any third party without NABFINS LIMITED's prior written approval.

The Bidder/Vendor shall ensure that complete confidentiality is maintained by them and all their personnel with regard to all information relating to NABFINS LIMITED. Unless required under law, Bidder/Vendor assures NABFINS LIMITED that neither Bidder/Vendor nor any of their personnel shall at any time divulge, disclose nor make known to any third parties any business process or date, trust, accounts, matters or transactions whatsoever pertaining to NABFINS LIMITED.

## 4. ORDER CANCELLATION:

NABFINS LIMITED reserves its right to cancel the entire/unexecuted part of the Purchase Order at any time by assigning appropriate reasons in the event of one or more of the following conditions:

- a) Delay in completion of work as per the scope of this tender, beyond 06 months from the date of acceptance/receipt/issue of the Work Order/Purchase Order (except with written permission from NABFINS LIMITED).
- b) Any other appropriate reason incidental to clause (a) above.

## 5. RIGHT TO ACCEPT OR REJECT THE BID:

NABFINS LIMITED shall reserve the right to accept/ reject and cancel the bid, amend the quantity under any lot or withdraw any lot at any stage before or after acceptance of bid/ issue of acceptance letter/sale order/delivery order/deposit of the full sale value by the bidder, without assigning any reason therefor and the value of such material, if paid for, shall be refundable. NABFINS LIMITED shall not be responsible for damage/loss to bidders on account of such withdrawal at any stage from the sale.

### 6. FORCE MAJEURE:

No Party shall be liable for any default or delay in the performance of its obligations under this Agreement, if and to the extent the default or delay is caused, directly or indirectly, by Force Majeure and provided that the non-performing Party could not have been prevented such default or delay.

The affected Party shall provide notice of non-performance due to Force Majeure to the other Party within 21 days after the start of such non-performance (or, if providing notice within such time frame is not commercially practicable due to Force Majeure, then as soon as possible thereafter) and such non-performance will be excused for the period such Force Majeure Event causes such non-performance; provided that if NABFINS LIMITED determines it is commercially

or technically infeasible to cure the Force Majeure and so notifies the bidder, then NABFINS LIMITED may terminate this Agreement effective immediately upon delivery of notice of termination to the bidder.

# 7. BID PRICE:

- a) The prices should be quoted in Indian Rupees only.
- b) All duties, taxes and other levies payable by the vendor shall be included in the total price. The cost of insurance, packing, forwarding and any other incidentals, etc. if any, shall be borne by the bidder and factored in while formulating the financial bid.
- c) The bidder needs to factor in the cost for all components/services, including supply, delivery, configuration and commissioning of CCTV surveillance system at branch offices, HO control room and AMC as per the Bill of Material.
- d) Corrections, if any, shall be made by crossing out, initialling, and re-writing.
- e) The rates quoted by the bidder shall be valid for 90 days from the date of opening of the financial bid.
- f) Each bidder shall submit only one bid. If more than one bid is submitted, all the bids submitted by the bidder shall be rejected.
- g) Price bids shall be signed by the person/s duly authorized by the Vendor/Bidder.

## 8. AWARD OF CONTRACT:

- 1. Eligibility-cum-Technical Evaluation If a Vendor/Bidder qualifies in the eligibility criteria and their technical offer meets all the technical specifications (Annexure II), only then they would be considered for technical evaluation i.e. technical presentation and other parameters.
- 2. Only those offers which obtain atleast **70% marks** in the technical evaluation will be considered eligible for opening of their financial bids.
- 3. **Quality and Cost Based System (QCBS)** The final techno-commerical evaluation of the offers shall be done based on QCBS method with weightage of 70:30 to technical evaluation and financial offer respectively by a duly constituted evaluation committee.
- 4. The Vendor/Bidder securing the maximum marks in the QCBS process shall be awarded the contract.

Notwithstanding the above, the purchaser reserves the right to accept or reject any bids and to cancel the bidding process and reject all bids at any time prior to the award of contract. **9. RIGHT TO ACCEPTANCE:** 

The Company does not bind itself to accept the lowest bid and reserves the right of accepting the whole or any part of the RFP or portion of the quantity offered, wherever applicable, and the bidder shall supply and install the same at the rate quoted.

The bidder, whose bid is accepted, will be notified for the award of contract by the purchaser prior to expiry of the quotation validity period (90 days from the opening of financial bid). The terms of the accepted offer shall be incorporated in the purchase order.

## **10. DELIVERY:**

The selected vendor shall complete the delivery, installation, configuration and commissioning of all the devices/software at the existing NABFINS branches and General Surveillance Management Centre at HO within 06 months from the date of issue of the Purchase Order/Work Order.

Further, in respect of NABFINS branches openend post 06 months from the date of issue of the Purchase Order/Work Order, the vendor shall complete the delivery, installation, configuration and commissioning of all the devices/software within 30 days of issue of notification of branch establishment from NABFINS.

## **11. TERMS OF PAYMENT:**

### **13. CONTRACT:**

NABFINS LIMITED will be executing the contract with the selected bidder for the supply, installation, configuration and commissioning of CCTV surveillance system for its branch offices (as per Annexure X), with a General Surveillance Management Centre at NABFINS HO, Bengaluru and 03 years' Annual Maintenance Contract for both branch offices and GSMC at HO. The AMC shall commence branch-wise from the date of commissioning of the CCTV surveillance at respective branch. The AMC period may be further extended by upto 02 years on mutually agreed terms, subject to cost escalation of maximum 5% year-on-year.

The prices quoted by the selected bidder will remain same during the contract period. Upon issue of Purchase Order, the selected bidder needs to supply, install and configure the CCTV

camera systems for existing and newly opened branches during the contract period without any additional cost escalation.

    - Atleast any 2 certifications 5 marks
    - Atleast any 3 Certifications 10 marks
    - All certifications 15 marks
  - c. Operations/Managed Services project (minimum Rs. 5.00 crore) running or having run for 1+ year in last 05 years
    - Atleast 1 project 5 marks
    - Atleast 2 projects 10 marks
    - Atleast 3 or more projects 15 marks
  - d. Surveillance project implemented over the last 05 years, with minimum 500 cameras
    - Atleast 1 project 5 marks
    - Atleast 2 projects 10 marks
    - Atleast 3 or more projects 15 marks

Bidder needs to score atleast 70% marks (out of 100) in technical evaluation in order to qualify for opening of the respective financial bids. However, if at least 02 bidders are unable to score atleast 70%, NABFISN, at its sole discretion, may consider relaxation of such threshold.

# Final Evaluation – Weighted Techno-Commerical Evaluation for determination of L1 vendor - Quality and Cost Based System (QCBS):

Only those offers which obtain atleast **70% marks** in the technical evaluation will be considered eligible for opening of their financial bids.

After opening of the financial bids, the final techno-commerical evaluation of the offers shall be done based on QCBS method with weightage of 70:30 to technical evaluation and financial offer respectively, by a duly constituted internal evaluation committee of NABFINS.

The proposals will be finally ranked according to their combined Technical bid score and Financial bid score (S) as follows:

S = (ST x Tw) + (SF x Fw)

Where

S = Combined score, ST = Technical Score of the bidder Tw = Technical weightage SF = Financial Score of the bidder Fw = Financial weightage

Formula for calculating SF and ST are as follows:

ST = (Technical Score of the bidder/ Highest Technical Score) X 100 SF = (Lowest Financial Figure / Bidder's Commercial Figure) X 100

The selected Bidder/Vendor having the highest combined score in the aforesaid manner, shall be treated as the first ranked Bidder/Vendor. NABFINS may also maintain a reserve list of Bidders/Vendors, which may be used in case the first ranked Bidder/Vendor withdraws or fails to comply with the requirements as the case may be.

Note:

- 1. The highest technical bidder shall not automatically qualify for becoming selected bidder and for award of contract by NABFINS.
- 2. The Successful bidder shall be the first ranked bidder (having the highest combined score). The final decision on the successful bidder will be taken by NABFINS.
- 3. If for some reason, the successful bidder fails to execute an agreement within a specified timeline, NABFINS reserves the right to award the contract to the next most eligible bidder based on the final evaluation scope of technical evaluation scores and financial prices quoted.
- 4. In case of a tie of Total Score between two or more bidders, the Bid with higher technical score would be chosen as the successful Bidder.
- 5. NABFINS will calculate the scores up to two decimal points only. If the third decimal point is greater than .005 the same shall be scaled up else, it shall be scaled down to arrive at two decimal points.

## **Other Terms & Conditions:**

- 1. On any issue or area of material concern regarding the RFP not specifically dealt with in the terms defined in the RFP, the decision of NABFINS shall be final and binding on all concerned.
- 2. The bidder whose technical and commercial bid is accepted will be referred to as the "Selected Bidder" and NABFINS will notify the same to the Selected Bidder.

- 3. The final decision on the vendor selection will be taken by NABFINS.
- 4. The implementation of the project shall commence upon successful negotiation of a contract between NABFINS and the selected bidder based on the evaluation.
- 5. If, for some reason, negotiations with the successful bidder fail to result in an agreement within a specified timeline, NABFINS reserves the right to award the contract to the next most eligible bidder based on the evaluation.

# NABFINS LIMITED hereinafter referred to as "The Principal"

## Preamble

The principal intends to award, under laid down organizational procedures, contract/s for the supply, installation, configuration and commissioning of CCTV cameras. The principal values full compliance with all relevant laws of the land, rules, regulation, and economic use of resources and of fairness/transparency in its relations with its Bidder(s) and/or Contractor(s). In order to achieve these goals, the Principal will appoint Independent External Monitor(IEM) who will monitor the tender process and the execution of the contract for compliance with the principles mentioned above.

## Section 1 -Commitments of the Principal

(1) The Principal commits itself to take all measures necessary to prevent corruption and to observe the following principles: -

- a) No employee of the Principal, personally or through family members, will in connection with the tender for, or the execution of a contract, demand, take a promise for or accept, for serf or third person, any material or immaterial benefit which the person is not legally entitled to.
- b) The Principal will, during the tender process treat all Bidder(s) with equity and reason. ## Section 2 -Commitments of the Bidder(s)/Contractor(s)

(1) The Bidder(s) / Contractor(s) commit themselves to take all measures necessary to prevent corruption. The Bidder(s) / Contractor(s) commit themselves to observe the following principles during participation in the tender process and during the contract execution:

- c) The Bidder(s)/Contractor(s) will not commit any offence under the relevant IPC/PC Act; further the Bidder(s) / Contractor(s) will not use improperly, for purposes of competition or personal gain, or pass on to others, any information or document provided by the Principal as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
- d) The Bidder(s)/Contractor(s) of foreign origin shall disclose the name and address of the Agents/representatives in India, if any. Similarly, the Bidder(s)/Contractors(s) of Indian Nationality shall furnish the name and address of the foreign principals, if any.
- e) The Bidder(s) /Contractor(s) will, when presenting their bid, disclose any and all payments made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the contract.
- f) Bidder(s) Contractor(s) who have signed the Integrity Pact shall not approach the Courts while representing the matter to IEMs and shall wait for their decision in the matter.

(2) The Bidder(s) /Contractor(s) will not instigate third persons to commit offences outlined above or be an accessory to such offences.

## Section 3 - Disqualification from tender process and exclusion from future contracts

If the Bidder(s) /Contractor(s), before award or during execution has committed a transgression through a violation of Section 2, above or in any other form which put their reliability or credibility in question, the Principal is entitled to disqualify the Bidder(s) / Contractor(s) from the tender process.

### Section 4 - Compensation for Damages

(1) If the Principal has disqualified the Bidder(s) from the tender process prior to the award according to Section 3, the Principal is entitled to demand and recover the damages equivalent to Earnest Money Deposit/Bid Security.

(2) If the Principal has terminated the contract according to Section 3, or if the Principal is entitled to terminate the contract according to Section 3, the Principal Shall be entitled to demand and recover from the Contractor liquidated damages of the Contract value or the amount equivalent to Performance Bank Guarantee.

### **Section 5 - Previous transgression**

### Section 8 - Independent External Monitor

(1) The Principal appoints competent and credible Independent External Monitor for this Pact after approval by the Central Vigilance Commission of NABARD. The task of the Monitor is to review independently and objectively, whether and to what extent the parties comply with the obligations under this agreement.

(2) The Monitor is not subject to instructions by the representatives of the parties and Performs his/her functions neutrally and independently. The Monitor would have access to all Contract documents, whenever required. It will be obligatory for him / her to treat the information and documents of the Bidders /Contractors as confidential. He / she reports to the Chairman, NABARD.

(3) The Bidder(s)/Contractor(s) accepts that the Monitor has the right to access without restriction to all Project documentation of the Principal including that provided by the Contractor. The Contractor will also grant the Monitor, upon his/her request and demonstration of a valid interest, unrestricted and unconditional access to their project documentation. The same is applicable to Sub-contractors.

(4) The monitor is under contractual obligation to treat the information and documents of the Bidder(s) /Contractor(s) / Sub-contractor(s) with confidentiality. The Monitor has also signed declarations on `Non-disclosure of Confidential Information and of `Absence of Conflict of Interest'. In case of any conflict of interest arising at a later date, the IEM shall inform Chairman, NABARD and recuse himself/herself from that case.

(5) The Principal will provide to the Monitor sufficient information about all meetings among the parties related to the Project, provided such meetings could have an impact on the contractual relations between the Principal and the Contractor.
