INTRODUCTION

NABFINS Ltd. intends to establish a panel of reputed IT auditing firms for a period of three years to undertake various IT audit assignments. Applicants may seek empanelment for one or more types of audits across different categories.

As outlined in Annexure I, the audits are classified into two categories: Category-1 and Category-2. Auditing firms may apply for empanelment under either category or both. Applicants must meet the General eligibility criteria mentioned in Annexure II. Which is application for both categories. In addition to general eligibility criteria, the applicants must meet the specific eligibility criteria, which is relevant to each category. Only those applicants who meet these eligibilities will be considered for inclusion in the panel.

NABFINS shall assign the audits, which is not listed in Annexure I, to the empanelled auditors during the 03 years validity of empanelment on mutually agreeable terms & conditions and cost.

General Eligibility

NABFINS will verify the documents submitted by the applicants and the scrutiny of the documents will be as per the general eligibility criteria (annexure II) mentioned in the empanelment document. NABFINS will be performing a thorough examination of supporting documents to meet each eligibility criteria as per annexure II and shall consider for category wise evaluation. (i.e., determine the Eligible applicant for empanelment.) Those applicants not complying with the general eligibility criteria are liable to be rejected and shall not be considered for category wise evaluation.

Technical Evaluation Criteria

Application submitted by the applicants will be evaluated only if they meet the eligibility criteria as detailed in Annexure II & III. The evaluation will be conducted based on a total score of 500 marks. The evaluation process will follow a defined matrix comprising the following parameters. Applicants are required to submit all necessary documentation in accordance with the Evaluation Criteria.

Applicants scoring at least the minimum score in the table above and an overall score of 300 marks or more will be declared technically qualified.

The applicants scoring less than 300 marks (cut-off score) out of 500 marks in the evaluation criteria shall not be considered for further selection process and their offers will be dropped at this stage.

In case none of the participating applicants qualifies on evaluation criteria by reaching or exceeding the cut off score of 60%, then NABFINS, at its sole discretion, may relax the cut-off score to a lower value, which, in any case, shall not fall below 50%. In case at-least two participants have not scored 50%, then NABFINS reserves the right to either cancel and go for re-empanelment process or follow any other process in line with NABFINS policies and procedures. However, this would be at the sole discretion of NABFINS.
